### **CURRENT POSITION:**

#### **Penn State Law—University Park, PA (2009-present)**

Professor of Clinical Law: I currently teach first-year Constitutional Law, Professional Responsibility, Law & (In)equity, and Human Rights, Intersectionality & the Law Seminar. I also advise the Arbitration Law Review, and co-chair the faculty Diversity Committee.

#### **Rutgers Law – Newark, NJ (January-May 2023)**

Visiting Professor of Law: I taught first-year Constitutional Law, and Professional Responsibility, at the Rutgers Law School in Newark, New Jersey during the spring 2023 semester.

#### **Penn State Law—University Park, PA (July 2019-December 2022)**

Associate Dean for Academic Affairs: Reporting directly to the Dean, I served as a key advisor for 2 successive deans, while managing the operations of all our academic programs. I also served the wider University on the Faculty Affairs Advisory Council for the Vice Provost for Faculty Affairs. As the law school's primary academic officer, I planned, delivered, and assessed all curricular matters for our JD, LLM, MLS, and SJD students. I oversaw our joint degree programs, including a new JD/Master's in Public Health that I developed, and an innovative "custom" joint JD that students can pair with any cooperating degree at Penn State University. I worked with interdisciplinary teams to launch new Master's in Legal Studies; Master's in Engineering, Law, & Policy; and Master's in Taxation degrees. I led the search for our transformative Assistant Dean of Student Services in 2019, and I oversaw the transition of our former Student Services Dean to Associate Dean for Academic Success. I transitioned our Registrar operations from a two-person team to one extraordinary performer using new technology and processes. I served on the Advisory Council for Penn State's Vice Provost for Faculty Affairs. In leadership of our faculty hiring efforts along with the Dean, I managed successful searches for numerous tenure-stream and other full-time faculty members. I independently hired and managed all our adjunct and visiting faculty. I led our academic integrity operations, often in collaboration with Penn State's Office of General Counsel.

Director, Family Law Clinic (2010-2019): Launched the clinic in January 2010. Grew it into one of our largest clinics, serving mostly domestic violence survivors. Added post-graduate fellows and grant-funded staff attorneys. I also taught Family Law and Professional Responsibility.

Director, Externships (2015-2019): Redesigned the program, adding Externships Everywhere, paid externships, and remote externships. Developed new curriculum and added two faculty.

Director, Public Interest Programs (2015-2019): Managed our IOLTA grant from the PA Supreme Court, which funds student public interest fellowships and the Family Law Clinic.

Adjunct Lecturer (2007-2009): I taught Family Law in traditional and hybrid classroom formats.

### **Key Accomplishments as Associate Dean for Academic Affairs**

- Managed the planning and delivery of remote courses and final exams during COVID as liaison between the faculty, student, and staff constituencies including our IT team.
- Led the move to a “credit/no credit” grading system in spring 2020, which entailed gathering extensive input from students and faculty in a collaborative style, including student representatives on the Curriculum Committee and numerous faculty meeting discussions.
- Co-chaired Penn State Law’s COVID teaching response team and developed a faculty “Teaching with Technology” workshop series and resource repository.
- Developed an online system for our COVID hybrid course delivery methods where students indicated their preferences for in-person or remote learning course-by-course.
- Rearranged all classrooms for elective courses to de-densify, while enabling students to attend classes in-person even with some faculty teaching remotely during COVID.
- Overhauled our first-year core curriculum to evenly distribute remote and in-person instructors evenly among all first-year students and courses during COVID.
- Chaired the 2019-20 search committee for our Assistant Dean for Student Services, resulting in an exciting hire that advanced the diversity of our leadership team and brought us important expertise in student well-being and racial justice.
- In response to the killing of George Floyd and others, granted our students’ request for a new Race, Equity, & the Law Concentration, and made the founding pledge to establish our George Floyd Memorial Scholarship (now over \$130,000.00 and growing).
- Helped develop Dean’s cabinet-style Administrative Coordinators Group.
- Established a Mental Health Awareness Week. and Well-Being Committee (co-chair).
- Implemented a Concentrations program, in response to student requests to enhance their employment opportunities, designed around our existing Specialized Fields of Study.
- Introduced numerous courses, including AI’s Past, Present and Future; Contract Drafting; COVID-19: Law & Tech Policy; Data & Democracy: Foreign Interference in Elections; Advanced Corporations; Employee Benefits & Equity Compensation; Federal Crimes; Food Law; Government Contracts; Human Rights, Intersectionality, & the Law; Land Use
